

CONSTRUCTION

Housing

Available in a Brushed Aluminum and powder coated White finish.

Surface Mounting

Aluminum extrusion with mounting canopy.

Recessed Mounting

Extruded aluminum housing and trim plate supplied with galvanized steel adjustable bar hanger assembly.

Panels

Constructed of clear acrylic. Universal kit includes a mirror panel with red lettering for double-face application and a clear panel with red lettering for single-face applications. Universal chevrons are field removable.

Illumination

High-output red LEDs provide superior brightness. Energy consumption of less than 3 Watts for AC only or less than 5 Watts for battery backup units. LEDs are a maintenance-free solution, providing up to 100,000 hours of use without failure.

ELECTRICAL

Input

Dual-voltage input 120/277VAC at 60Hz.

Nickel Cadmium Battery – NiCad (With Battery Only)

Mule Lighting NiCad batteries are maintenance-free and continue to perform in a vast temperature range from 0°C to 40°C (32°F to 104°F).

Emergency

The NY-PVTU Series exit will operate for a minimum of 90 minutes during a loss of power with a 24 hour maximum recharge time for the battery.

Low Voltage Disconnect (LVD)

The LVD continuously monitors the battery terminal voltage and if it should fall below a preset voltage threshold, the LVD will disconnect the load. When the battery is recharging and voltage is raised above another preset voltage threshold, the load is automatically reconnected.

Damp Location Rated

Damp Location Rated fixture that is normally or periodically subject to condensation of moisture in, on or adjacent to, and includes partially protected locations.

Test Button

The test button is easy to locate and provides manual verification of the transfer circuit and emergency lamps.

INSTALLATION

Surface Mounting

Completely universal canopy includes end or ceiling mounting. All hardware is included.

Recessed Mounting

Recessed ceiling and recessed wall mount includes trim plate and hanger bars for grid install. Electronics and battery contained in housing. Plug-in battery connector supplied for easy installation. All hardware is included.
